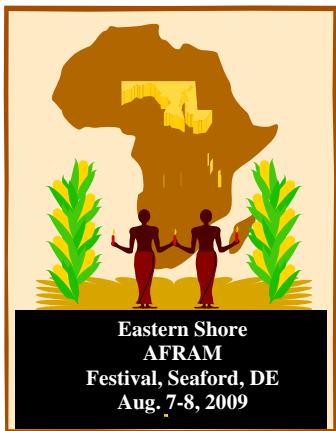

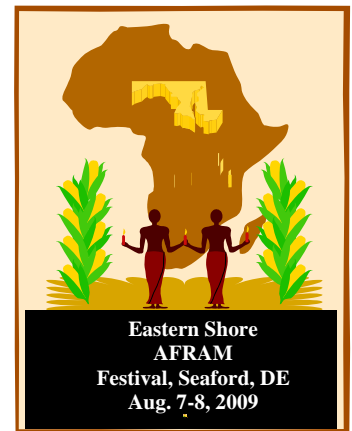

Details

1. Vendor contracts are due no later than May 1, 2009 in order to get “Early Bird” discount price.
2. All food vendors must complete and return a Board of Health Food permit. This is mandatory.
3. Vendors are responsible for any/all inspections, permits and/or licenses, as required by law.
4. You will only be permitted to sell those items listed on your contract.
5. Vendors are prohibited to sell drugs, alcoholic beverages, offensive apparel, or loud toys. If you are unsure of a product, please ask before displaying.
6. Set-up will begin at 12 p.m. on Friday, Aug. 7th and 7:00 a.m. on Saturday Aug. 8th. Please check in at the AFRAM Information booth before setting up. Once you have set-up, your vehicles must be moved to the designated parking area. There will be no exceptions.
7. Vendor spaces have been increased to 12' x 12'. If you feel you will need more than the allotted space to provide seating for your patrons, condiment stands, etc., you may purchase one additional space: *Food vendors - \$175 (2 spaces); Non-food vendors - \$85 (2 spaces); Non-profit - \$50 (2 spaces).*
8. All vendors are required to furnish their own tents, tables and chairs. (*Tents / Canopies are mandatory for this year's festival*).
9. The Festival will occur rain or shine. Registration fees are non-refundable.
10. AFRAM does not provide electrical hook up! B.Y.O.G.(Bring your own Generator)

Vendors who do not comply with the rules and regulations stated above will be automatically removed from the festival and will not be allowed to participate in future events sponsored by the Eastern Shore AFRAM.

DIRECTIONS TO NUTTER PARK

From the north: Take I-95 South to DE Route 1 South, which changes to US Route 13 South to Seaford. At the McDonalds, turn right onto Norman Eskridge Highway...

From the South: Take US Route 13 North to Seaford. At the McDonalds, turn left onto Norman Eskridge Highway...

Follow Norman Eskridge Highway to the second traffic light where you will turn left on Chandler St. Turn right onto Collins Ave and Nutter Park will be on the right.
